FROM THE DIRECTOR GENERAL'S DESK

Code on Wages, 2019: Universalisation of Minimum Wages for all Workers

The Code on Wages (CoW) Bill 2019, which is first in a series of four labour codes proposed in the government's labour reform initiative received assent of the President on August 8, 2019. The CoW, 2019 has amalgamated, simplified and rationalized relevant provisions of the following four central labour enactments relating to wages, namely: (a) the Payment of Wages Act, 1936; (b) the Minimum Wages Act, 1948; (c) the Payment of Bonus Act, 1965; and (d) the Equal Remuneration Act, 1976. The CoW provides for all essential elements relating to wages, equal remuneration, its payment and bonus. The overall objective of the CoW is to facilitate better implementation and effective enforcement without compromising on the basic concepts of welfare and benefits to workers.

Some of the salient features of the CoW, 2019, *inter alia*, are as follows:- (a) provisions relating to wages shall be applicable to all employments covering both organised and un-organised sectors; (b) power to fix minimum wages continues to be vested in the Central and State Government as per their respective sphere; (c) enables appropriate Government to determine and fix minimum wages for different category of employees taking into account skills, arduousness of work, geographical location and other aspects; (d) provisions relating to timely payment of wages and authorised deductions from wages have been made applicable to all employees irrespective of wage ceiling; (e) provides for payment of wages to employees also through cheque or digital or electronic mode or by crediting to the bank account; (f) provides for floor wage for different geographical areas so as to ensure that no State Government fixes the minimum wage below the floor wage; (g) in order to remove arbitrariness and malpractices

in inspection, it empowers appropriate Government to appoint Inspectors-cum-Facilitators, who would supply information and advice to employers and workers; (h) empowers appropriate Government to determine ceiling of wage limit for the purpose of eligibility and calculation of bonus; (i) enables the appropriate Government to establish an appellate authority to hear appeals for speedy, cheaper and efficient redressal of grievances and settlement of claims; (j) provides for graded penalty for different types of contraventions of the provisions of the code; (k) provides that where a claim has been filed for nonpayment of remuneration or bonus or less payment of wages or bonus, the burden shall be on the employer to prove that the said dues have been paid to the employee; (1) enables the appropriate Government to constitute Advisory Boards at Central and State level to advice, on matters relating to wages, women employment, etc.

In short, the provisions of the CoW are balanced – while on the one hand, by universalizing the minimum wages, it promotes equity, on the other, by facilitating ease of compliance, it promotes setting up of more enterprises thereby catalyzing creation of more employment opportunities.

Silent Features of CoW and Impact

Workers:

- Legal right of getting wage not less than minimum wage to all 50 crore workers
- Timely payment to all, irrespective of wage limit
- A Floor Wage below which minimum wage can't be fixed by State

Employers:

- Hassle free compliance online one register, one form and one return
- Simple clear uniform definition of wage reduced compliance costs

Impact:

- Universalizes the legal right to get wages not less than minimum wages & timely payment of wages to all workers of all sectors.
- Introduces the concept of National Minimum Floor Wage to check regional disparity in minimum wages.
- Reduces the existing number of minimum wages for effective enforcement.
- Uniform definition of wages.
- Transparent, accountable and jurisdiction-free web-based inspection system.

National Labour Administration systems have a crucial role in conception and implementation of national labour National Labour Administration systems have a crucial role in conception and implementation of national labour policies. Many governments have thus recently taken efforts to modernize their labour administration systems and increase their performance by implementing various types of administrative reforms such as improving planning and coordination, introducing performance management schemes or using new technologies especially in management processes and in providing services to the public. Some of them have also taken measures to reach out to the informal sector which is largely beyond the scope of labour administration in many parts of the world. Also, many labour administrations in both developed and developing countries have been trying to increase compliance with labour laws. The State through its labour administration system bears a heavy responsibility in the social field most importantly to safeguard the fundamental human rights of workers.



However, the main challenge before the labour administration system in India today is the large informal economy and limited of coverage of workers in the informal and non-regular forms of the employment. The present government has embarked on a major labour law reform agenda with the objective of addressing informality and bringing unorganized workers in the purview of labour laws. In this background, the present study is an effort in the direction of highlighting the reforms undertaken in the states of Gujarat, Madhya Pradesh and West Bengal and identifying their similarities and differences in approach.

TRAINING PROGRAMMES

INTERNATIONAL TRAINING PROGRAMMES (ITP)

International Labour Standards and Promotion of Gender Equality in the Workplace (August 05-23, 2019)

The training programme was conducted in collaboration with the Ministry of External Affairs, Government of India under the ITEC-SCAAP scheme of the Ministry. The specific objectives of the programme were: (i) to provide a conceptual understanding about the international labour standards in the world of work; (ii) to understand the various international labour standards/international instruments and good practices on gender equality; (iii) to sensitize the participants about the existing legal and national polices on promotion of gender equality at the workplace; (iv) to analyse gender inequalities and discriminatory practices with regard to access to labour market, wages, working conditions, employment security, etc; (v) to understand the gendered vulnerabilities and



intersection of paid work and unpaid/care work, challenges in reconciling paid work and family responsibilities that leads women to precarious forms of employment that remain outside the purview of available legal and policy responses; (vi) to discuss about strategies of promotion of rights to fair/decent work and care within the framework of employment law and policies that would address the larger question of equality of opportunity and women's employment and sustenance in the labour market. The programme was attended by twenty five participants from fourteen (ITEC/SCCAP) partner countries namely; Kenya, Tanzania, South Sudan, Mongolia, Uzbekistan, Zimbabwe, Iraq, Guatemala, Tajikistan, Trinidad & Tobago, Kazakhstan, Ethiopia, Burundi and Sri Lanka. The participants were officials dealing with gender issues, human resource, administration, researchers from government departments, public departments, educational institutions etc. and others from different line Ministries. The programme was inaugurated by Ms. Meenakshi Gupta, Member Secretary, National Commission for Women, New Delhi and Dr. H. Srinivas, Director General, V.V. Giri National Labour Institute welcomed the participants. The valedictory address was delivered by Ms. Indrani Mazumdar, Centre for Women's Development Studies, New Delhi. Corporate Social Responsibility and Industrial Relations (July 29- August 2, 2019)

The main objectives of the training programme were: (i) to acquaint with the concept of Corporate Social Responsibility (CSR); (ii) to examine the key determinants of CSR; (iii) to understand various CSR/Sustainability Reporting Standards and Guidelines at the global level; (iv) to familiarize with CSR disclosure initiatives in India; (v) to assess Business Responsibility Report of Companies working in India; (vi) to develop strategies for promoting well-being of the employees through CSR. Enhancing Leadership Skills for Safai Karmacharis (July 29-August 02, 2019)

The specific objectives of the programme were: (i) to impart knowledge and information about the situation of Safai Karmacharis in India; (ii) to enhance inter-personal communication, leadership skills and team building among the participants; (iii) to discuss the legal protections in various labour legislations. Developing Skill Development Strategies for Women Workers in the Informal Economy (August 19-23, 2019)

The specific objectives of the programme were (i) to discuss the nature and characteristics of the informal economy; (ii) to situate the importance of skill development in the functioning of informal economy from gender perspective; (iii) to share the experiences of various social partners in skill development and training; (iv) to discuss appropriate strategies for skill development of women in the informal sector occupations. Enhancing Leadership Skills of Fishery Workers (August 26-30, 2019)

The specific objectives of the programme were: (i) to impart knowledge and information about fishery industry in general and status of workers in particular; (ii) to enhance inter-personal communication; (iii) to discuss the legal protections in various labour legislations; (iv) to familiarise on the various aspects of welfare funds. The training programme was attended by nineteen participants. **Dr. Ramya Ranjan Patel**, Associate Fellow was the Course Director.

Leadership Development Programmes for Rural Trade Union Leaders (August 26-30, 2019)

The specific objectives of the programme were: (i) to develop/sharpen skills of rural trade union leaders to understand, study, analyze rural society; (ii) to provide insights into dynamics of inter-personal and inter-group relationships; (iii) to discuss various issues and aspects related to organization building; (iv) to create awareness about legal rights and provisions; (v) to create awareness of prospective leaders about various social protection and employment policies; (vi) to make the participants aware about the emerging techniques of organizing rural workers; (vii) to help in locating the resources at the macro and micro level. The programme was attended by forty-seven participants. **Dr. Manoj Jatav**, Associate Fellow was the Course Director.

RESEARCH METHODS PROGRAMME (RMP)

Course on Research Methods on Gender, Poverty and the Informal Economy (August 26-September 06, 2019)

The specific objectives of the programme were to: (i) develop sufficient understanding of research methods particularly, compares and contrasts, analytical and methodological frameworks used in various studies related to gender, poverty and the informal economy; (ii) understand various concepts and theories related to gender, poverty and the informal economy research; (iii) learn an overview of qualitative and quantitative research methods; (iv) identify research gaps and propose directions for future work. The programme was attended by twenty-four participants. **Dr. Dhanya MB**, Associate Fellow was the Course Director.

CHILD LABOUR PROGRAMMES (CLP)

Conducting Child Labour Survey (July 2-4, 2019)

The programme aimed at developing understanding on various aspects relating to the issue of child labour, equipping with skills for developing survey formats and data elicitation tools for conducting child labour surveys, and for their administration in the field. They were also imparted training for formulating and designing programmes and implementing interventions. The programme was attended by sixty participants representing eleven states and twenty-three districts including some of the source and destination districts of child labour. **Dr. Helen R. Sekar**, Senior Fellow was the Course Director.

Identification and Rescue of Migrant and Trafficked Children and Adolescents (July 30 - August 01, 2019)

The specific objectives of the programme were: (i) to impart understanding of the legal provisions and the objectives of child labour laws; (ii) to provide knowledge of international and national protocols on the issue of human trafficking; (iii) to explore innovative ways to address trafficking of children/adolescents for labour exploitation; (iv) to identify challenges and evolve strategies to address the difficulties in ensuring child protection; (v) to acquire sharper understanding of the relevant standard operating procedures of MoLE and MHA. The programme was attended by thirty nine participants representing ten states and twenty five districts. **Dr. Helen R. Sekar**, Senior Fellow, was the Course Director.

Convergence for Ending Child Labour and Ensuring Child Protection (August 06-08, 2019)

The specific objectives of the programme were: (i) to enable the participants to understand the definitions of 'child' and 'child labour'; (ii) to understand causes and forms of child labour; (iii) to understand the magnitude and geographic spread of child labour; (iv) to equip the participants with abilities towards forging convergence among various schemes focusing on child labour families; (v) to impart skills of identifying children at work for effective rehabilitation; (vi) to share successful experiences of child labour prevention and elimination. The programme was attended by seventeen participants. **Dr. Helen R. Sekar,** Senior Fellow, was the Course Director.

NORTH-EASTERN STATES PROGRAMMES (NEP)

Promoting Entrepreneurship through Skill Development (July 15-19, 2019)

The programme aimed at putting increasing emphasis on the skills of workers in general and women workers in particular for enhancing employability and also to facilitate for decent employment and entrepreneurship. Forty nine delegates from north eastern states participated in the programme. The delegates also participated in the tree plantation drive organised by the Institute in commemoration of the 150th Birth Anniversary of Mahatma Gandhi. **Dr. Otojit Kshetrimayum**, Associate Fellow was the Course Director.

Social Protection and Livelihood Security for North Eastern States (July 15-19, 2019)

The objectives of the programme were: (i) to understand the livelihood risk and vulnerability of the rural poor; (ii) to understand the different social protection programmes that transfers assets and skills of people for self-employment and public works programmes that enable people to cope with poverty; (iii) to explore the alternative coping strategies/good practices for poverty reduction. The programme was attended by forty participants from North Eastern states. **Dr. Dhanya MB**, Associate Fellow was the Course Director.

Fundamentals of Labour Laws for Trade Union Leaders and NGOs from North-Eastern States (August 19-23, 2019)
