FROM THE DIRECTOR GENERAL'S DESK

India and the ILO

The International Labour Organisation (ILO) was founded in the year 1919, in the wake of World War–I, to pursue a vision based on the premise that universal, lasting peace can be established only if it is based on social justice. The ILO is a specialized agency of the United Nations (UN). India is a founding member of the ILO Governing Body since 1922.

The ILO is a tripartite agency that brings together governments, employers and workers of 187 member countries to set labour standards, develop policies and devise programmes promoting decent work and dignity for all women and men by according an equal voice to all the partners. In support of its goals, the ILO offers unmatched experience and knowledge about the world of work, acquired over almost 100 years of responding to the needs of the people. It serves its tripartite constituents and society at large, in a variety of ways viz. formulation of international policies and programmes to promote workers interests, improve the working and living conditions of workers; create international labour standards; international technical cooperation formulated and implemented in active partnership with its constituents, etc.

The ILO's overarching goal is Decent Work (DW) for all and the DW concept is translated into Decent Work Country Programmes (DWCP), prepared and adopted by the tripartite constituents and ILO at the country level. The DWCP-India focuses on three priorities viz. promote, adopt and implement international labour standards for protection of workers from unacceptable forms of work; create sustainable, inclusive and decent employment for women and youth, especially vulnerable to socio-economic and environmental exclusion and in the informal economy and protecting rights of workers through promoting labour administration and tripartite mechanism, occupational safety and health (OSH) and social protection. Recognising the important role which India could play in the international arena, the ILO has been promoting India's role in broader agendas of the ILO such as the Future of Work, Sustainable Development Goals (SDG's), G20, BRICS (Brazil, Russia, India, China and South Africa), and IBSA (India, Brazil and South Africa) Dialogue Fora. Other additional opportunities that are a result of emerging south-south and triangular cooperation such as those involving V. V. Giri National Labour Institute-International Training Centre of ILO, Turin are also proposed to be leveraged.

Following the onset of Industrial Revolution 4.0 and rapid transformations taking place in the world of work, the ILO had constituted a Global Commission to study the future of work. The commission which had a representation from India too, has proposed a human-centered approach for the future of work that strengthens the social contract by placing people and the work they do at the centre of economic and social policy and business practice. The commission suggested three broad actionable points viz. increase investment in people's capabilities, increase investments in the institutions at work and increase investment in decent and sustainable work.



SPECIAL EVENTS

Impact on Employment of the Maternity Benefit (Amendment) Act, 2017: Identifying the Affirmative Initiative and Challenges in the Implementation of the Act

(November 22, 2019)

The primary objective of the workshop was to identify the challenges and constraints in the implementation of the Maternity Benefit (Amendment) Act 2017 and its impact on the employment and recruitment of women. Dr. H. Srinivas delivered the introductory remarks and Shri Rajan Verma, Chief Labour Commissioner, Ministry of Labour & Employment, Govt. of India delivered opening remarks on the occasion. The workshop was chaired by Shri Surendra Nath, IAS (Retd.). Thirty four participants attended the workshop. **Dr. Shashi Bala**, Fellow was the workshop coordinator.



ILO-VVGNLI National Tripartite Social Dialogue Workshop at LNML MILS, Mumbai. (December 09, 2019)

This workshop was organized by V.V. Giri National Labour Institute in collaboration with the International Labour Organisation (ILO) at LNML-Maharashtra Institute of Labour Studies, Mumbai. The workshop aimed at (i) sharing the findings of the recently conducted research by the ILO in the area of prevailing social dialogue practices in respect of Maharashtra, Kerala and Tamil Nadu; (ii) identifying the technical support required by other states to strengthen social dialogue; (iii) identifying possible action to strengthen social dialogue at the national level. The workshop was attended by thirty participants. **Dr. Sanjay Upadhyaya**, Senior Fellow coordinated the workshop.



Sanrachna 2019 (December 04-06, 2019)

V.V. Giri National Labour Institute participated in the 'Sanrachna 2019', a three day exhibition during December 04-06, 2019 at Kathua, Jammu & Kashmir in which awareness generation was made about various schemes launched by the government of India. Complexity in the Determination of Minimum Wages for Domestic Workers in India NLI Research Studies Series No. 137/2019

In the recent years some of the states have devised social security schemes and Welfare Boards for the domestic workers. Domestic work have been included as a scheduled employment under the Minimum Wages Act 1948 by some states and necessary gazette notification have been issued to that effect. However, till date no state has determined/declared minimum wage for the domestic work. In this context, the present study looks into the complexity in determination of minimum wages for domestic workers from both technical as well as normative perspective and their legal inclusion. The study is based on analysis of working conditions of domestic workers in two cities namely Kolkata and Ahmedabad.

LABOUR ADMINISTRATIVE PROGRAMMES (LAP)

Labour & Employment Issues for 70th batch IRS (C&CE) Officers (November 5, 2019)

A one day Orientation Programme on Labour and Employment Issues was conducted for the 70th batch IRS (C&CE) Officers. The programme was attended by fifty two IRS officers, who were undergoing training at National Academy of Customs, Indirect Taxes & Narcotics (NACIN), Faridabad. The programme was inaugurated by **Ms. Vibha Bhalla**, Joint Secretary Ministry of Labour & Employment, GoI. **Dr. H. Srinivas**, Director General of the Institute presided over the sessions and delivered the Valedictory Address. The programme was coordinated by **Dr. Ellina Samantroy**, Fellow .



Good Governance through Labour Administration and Labour Inspection (November 25-29, 2019)

The programme aimed at enhancing enforcement competence and skills of enforcement officers. The specific objectives of the programme were to: (i) have an understanding of the context of labour legislations in India; (ii) have knowledge of substantive as well as procedural contents of different labour laws; (iii) develop understanding with regard to new directions in labour laws and judicial interpretations; (iv) explore ways for optimum utilization of existing resources. The programme was attended by twenty one Assistant Labour Commissioners, Labour Enforcement Officers and Labour Inspectors from various states. **Dr. Otojit Kshetrimayum**, Fellow was the Course Director.

INDUSTRIAL RELATIONS PROGRAMMES (IRP)

Training Programme on Occupational Safety, Health and Welfare in a Globalizing Economy (November 25-29, 2019)

The major objectives of the programme were: (i) provide an overview on the changing labour market and employment relations; (ii) understand the changing role of social partners in the context of transformations in the world of work; (iii) provide an overview of international standards in the area of Occupational Safety and Health (OSH); (iv) develop insight on the existing legal instruments on Occupational Safety and Health (OSH) in the Indian context. The programme was attended by twenty two participants representing Officers from Inspectorate of Factories under State Labour Departments and senior representatives from management and unions from different Public and Private Sector undertakings. **Dr. Ruma Ghosh**, Fellow was the Course Director.

Managing Work Effectively: A Behavioural Approach (December 09-12, 2019)

The specific objectives of the programme were: (i) familiarize participants with various aspects of organisational development and culture; (ii) know more about work and office management; (iii) get familiar with work culture and ethics; (iv) know about various behavioural skills and its importance. CAPACITY BUILDING PROGRAMMES (CBP)

Training Programme on Gender, Work and Health (November 04-08, 2019)

The specific objectives of the programme were: (i) develop a conceptual understanding on the issue of gender, work and health; (ii) understand changing labour market and employment relations and its impact on health and safety of workers in the informal economy; (iii) address the specific risks and health problems facing women workers in the informal economy; (iv) understand the different OSH programmes/schemes and good practices for ensuring safety and health at workplace both at national and international levels. Training of Trainers Programme for Rural Educators (November 04-08, 2019)

The specific objective of the programme were: (i) develop understanding of rural society and changing role of labour; (ii) understand the changing role of labour and informal sector; (iii) develop skills for enhancing leadership, communication and team building; (iv) acquaint participants with labour laws on social security and on the welfare funds for unorganized sector. The training programme was attended by twenty eight participants. **Dr. Shashi Bala**, Fellow was the Course Director.

Leadership Development Programme for Domestic Workers

(November 11-15, 2019)

The specific objectives of the programme were: (i) enhance leadership skills among the domestic workers; (ii) provide awareness on national policy on domestic workers; (iii) address issues pertaining to domestic workers; (iv) increase communication skills among domestic workers. The training programme was attended by twenty participants. Dr. Shashi Bala, Fellow was the Course Director.

Leadership Development Programme for Tea Garden Workers (November 25-29, 2019)

The specific objectives of the programme were: (i) discuss various issues of labour working in tea gardens; (ii) develop skills and techniques for effective organisation building; (iii) foster skills of effective leadership. The training programme was attended by sixteen participants. Dr. Ramya Ranjan Patel, Associate Fellow was the Course Director.

Orientation Programme on Labour and Development Issues (December 02-06, 2019)

The major objectives of the programme were: (i) understand world of work, future of work and decent employment; (ii) make the participants acquainted with various labour and development issues; (iii) discuss important initiatives to address the issues; (iv) enable participants to contribute in their academic and professional work. Leadership Development Programme for BMS Members (December 3-6, 2019)

Labour Market Analysis (November 11-15, 2019)

The specific objectives of the programme were: (i) examine the various concepts and theories related to labour market; (ii) obtain deeper understanding of the key indicators of labour market; (iii) acquire knowledge about different sources of data on labour; (iv) sharpen skills in undertaking labour market surveys. Course on Qualitative Methods in Labour Research December 16-27, 2019

The major objectives of the Course were: (i) address various concepts and theories related to labour; (ii) familiarize participants with the different schools of thought in qualitative research; (iii) equip participants with the understanding and applicability of various qualitative methods; (iv) develop capacity to analyse and interpret qualitative data. CHILD LABOUR PROGRAMMES (CLP)

Repatriation, Rehabilitation and Reintegration of Child Labour (November 19-21, 2019)

The specific objectives of the programme were: (i) enhance the understanding of the participants on the procedures, and the stakeholders' role and responsibilities; (ii) develop skills for resource mobilization; (iii) highlight the importance of convergence of efforts and services for rehabilitation and reintegration; (iv) equip the participants to contribute towards effective implementation of various projects relating to child labour and child protection. The programme was attended by thirty seven participants. Dr. Helen R. Sekar, Senior Fellow, was the Course Director.

Educational Rehabilitation of Children Rescued from Different Forms of Labour Exploitation (December 10-12, 2019)

The specific objectives of this training programme were: (i) equip them skills on the pedagogical methodology for enabling joyful learning; (ii) discuss and analyze area-specific determinants for incidence of child labour (iii) enhance understating on the importance

of ensuring effective rehabilitation of children in NCLP/ STCs and their subsequent mainstreaming into formal education. The programme was attended by thirty three participants. Dr. Helen R. Sekar, Senior Fellow was the Course Director.

INTERNATIONAL TRAINING PROGRAMMES (ITP)

International Training Programme on Labour and Employment Relations in a Global Economy (November 04-22, 2019)

This training programme was conducted under the aegis of the ITEC Scheme of the Ministry of External Affairs, Government of India at the Institute's Campus. The specific objectives of the programme were to:(i) understand and appreciate the changing labour market and employment relations scenario in the context of globalisation;(ii) acquire knowledge about the changing role of social partners in the context of transformations in the world of work; (iii) learn and share experiences on new forms of labour management practices; (iv) develop positive attitude towards work, superiors, peers and subordinates. The programme was attended by thirty one senior and middle level officials dealing with labour and



related issues from nineteen Asian and African countries. Dr. S.K.Sasikumar, Senior Fellow was the Course Director.

International Training Programme on Gender Issues in the World of Work (December 02-20, 2019)

The training programme was organized under the auspices of the ITEC scheme of the Ministry of External Affairs, Government of India. The specific objectives of the programme were: (i) deliberate on the key concepts and approaches pertaining to gender; (ii) discuss the gender dimensions related to key labor market Indicators; (iii) study existing policies through gender lens; (iv) recognize the equality and access issues in the labour market participation. Understanding Labour Market and Employment Opportunities (December 16-20, 2019)

This programme was jointly organised by V. V. Giri National Labour Institute in collaboration with the National Institute for Career Service under the Ministry of Labour and Employment, Govt. of India. The aim of the training programme was to make the participants aware of the labour market trends, employment and entrepreneurship opportunities in the North East and the important role being played by National Career Service Project. The training was attended by twenty participants. Dr.Otojit Kshetrimayum, Fellow was the Course Director.

Gender, Work and Social Protection (December 26-28, 2019)

This training programme was conducted in collaboration with State Labour Institute, Odisha (SLI). and nature of vulnerabilities among women across social groups; (iv) address the issues of women's unpaid work, care work and other domestic responsibilities in informing polices on social protection. Social Security for Unorganized Workers December, 26-28, 2019

The objectives of the programme were: (i) make the participants acquainted with various inequalities existing in the work and coverage of social security, (ii) sensitize the participants about the legislative framework for social security, social security schemes for workers, and the unique practices in the country; (iii) familiarize the participants with labour laws and social security provisions. Training Programme on Quantitative & Qualitative Methods in Labour Research (December 30-January 03, 2019)
